Indoor swimming parties are semi-private. Semi-private includes the use of the pool for two hours with the availability to use a designated area for refreshments you wish to provide. Parties can be scheduled Friday/Saturday/Sunday at the Y facility. Toys are permitted with the exception of inflatable's such as rafts or mermaid tails. All children under age 8 are required to have an adult with them in the pool. The indoor pool starts at 3ft and ends at 12 ft with a diving board. To swim in the deep end of the pool all participants under the age of 18 will be required to pass a swim test administered by the lifeguard on duty.

Pool Parties:

- Reservations must be made at least 2 weeks in advance. Pool parties must be paid for at the time of reservation, in order for your date to be saved.
 - Everyone that comes to the pool party must sign the liability waiver at the Front Desk upon entering the building.
 - All pool parties are 2 hours. This includes any time used in the commons area or in the pool area.
 - The party should provide their own decorations, refreshments, etc. and are responsible for all clean up of these items.
 - Cameras are not permitted in the locker rooms.
 - The Twin Pike Family YMCA is not responsible for lost or stolen items.
 - All children under 8 years old must be supervised by an adult or sibling over 13 years of age.
 - A swim test will be administered to any child under 18 or to any person the life-guard may be concerned about in regard to their swimming ability.
 - Bathing suits are required for all swimmers, any swimmer 3 years and under must wear a swim diaper in the pool at all times.
 - Smoking and alcoholic beverages are not permitted inside the YMCA or on the YMCA grounds or at facilities managed by the YMCA.
 - Cancellation of the party in writing with fewer than 3 days notice or a “no show” on the date of the party will result in a full loss of dues paid.
 - If there are unforeseen circumstances that cause the pool to be closed, we will offer you an alternative date.
 - All participants must follow all posted pool rules.
 - Any organization booking a party will need to provide a certificate of insurance.
